Please note:

1. The Ombrosa teacher in charge will **make an appointment to meet you at home** from **November to March** to discuss the French children's visit and to answer any questions you may wish to rise.

3. French families will contribute £70 per week of stay to their hosts, mainly as a help towards food or outings. An envelope with the total amount should be given to you by the French child on his/her arrival.
4. Completed questionnaires **should be returned to your child's school** for posting on to France **as soon as possible**.
5. Ombrosa asks for each hosting parent to take a regular **DBS check**. Ombrosa will give a full refund if there are any fees involved in this procedure.

GDPR (General Data Protection Regulation)

Our organisation, Enseignements et Loisirs Educatifs, 50 rue Vendôme 69006 Lyon, which is responsible for running the educational establishment OMBROSA, collects information by means of this form.
